## Municipality of Nevşehir Cappadocia 8<sup>th</sup> International Photography Contest

### **Subject of Contest:**

“Landscape”

### **Categories of the Contest**

Contest is in one category including digital monochrome or color photographs.

### **Terms of Contest:**

1. Jury members, TFSF (Photographic Arts Federation of Turkey) representative and their first degree relatives cannot participate to the contest.
2. Participation is free of charge.
3. As the photographs will have documental characteristics it is not allowed to make any arrangements except the basic arrangements such as color, contrast and cropping. The photographs must be comply with the definition of traditional photo (TRAD)\* by FIAP.
4. Experimental works will not be accepted.
5. Each contestant may participate with maximum 4 (four) Digital Color or Black & White photographs.
6. The photographs which are awarded and exhibited in previously organized Cappadocia Photography Contests of Nevşehir Municipality contests cannot participate in the contest. Any act to the contrary will be considered as a violation of rules.
7. The Participant declares and confirms that the photograph sent to the contest totally belongs to him/her all required permissions are granted/completed. Rule violation process is applied about the participants who violate this statement and acceptances. The participant accepts, declares and commits that any legal issues about his/her photos will be under his/her responsibility.
8. Rule violation process is applied about the participant who submits a copyright which does not belong to him/her, executes any alterations or changes on the photo that does not belong to him/her to mislead the jury.
9. The disqualified individuals shall be subject to sanctions further to Article 13 of the Regulations of National/International Competition Organization Standards of the TFSF (TR: [http://www.tfsf.org.tr/indir/yarismalar/TFSF\\_Yarisma\\_Duzenleme\\_Standartlari\\_Yonergesi-YG\\_002-9-24\\_05\\_2016.pdf](http://www.tfsf.org.tr/indir/yarismalar/TFSF_Yarisma_Duzenleme_Standartlari_Yonergesi-YG_002-9-24_05_2016.pdf) ENG: [http://www.tfsf.org.tr/en/download/contest\\_regulatory\\_standards.pdf](http://www.tfsf.org.tr/en/download/contest_regulatory_standards.pdf)). The award, title, and any kind of earnings obtained from the contest shall be withdrawn from the competitors who are found to be acting outside of this statement and provisions. If participants violate the competition conditions, their awards will be cancelled. The award will not be replaced with a new one and the ranking and award will be left empty. The FIAP will be also informed about the situation.  
The photographers, who are still in the list of limitation decision by TFSF and are at FIAP's Red List, cannot participate to this contest.
10. Organizer institution will identify the participants who are in the limitation decision list of TFSF and FIAP's Red List and eliminate them before Jury Assessment.
11. With the sole act of submitting his/her images or files to a salon under FIAP Patronage, the

entrant accepts without exception and with no objection that the submitted images can be investigated by FIAP to establish if these obey to FIAP regulations and definitions even if the entrant is not a member of FIAP; that FIAP will use any means at its disposal for this undertaking; that any refusal to cooperate with FIAP or any refusal to submit the original files as captured by the camera, or failure to provide sufficient evidence, will be sanctioned by FIAP and that in case of sanctions following the non-compliance with FIAP regulations, the name of the entrant will be released in any form useful to inform the breaches of the rules. It is recommended to leave the EXIF data in the submitted files intact in order to ease eventual investigations.

12. All parts of the image have to be photographed by the author who is holding the copyright of all works submitted.
13. In the general interest of the event, the reproduction of the remitted works is allowed in the printed or digital catalogue, except when expressly prohibited by the author. In this matter the rules about copyright have to be strictly followed. Under no circumstances the organiser is allowed to use the pictures handed in for other purposes.
14. Nevşehir Municipality may ask the original files of the award and exhibition winning photographs from the participant.
15. Results of the contest will be announced at the official website of Municipality of Nevşehir [www.nevsehir.bel.tr](http://www.nevsehir.bel.tr), <http://www.tfsf.org.tr> and <http://tfsfonayliyarismalar.org>; and also will be notified to all participants by e-mail.

### **Right of Publishing and Copyright (Use)**

1. A copy of the photographs which are awarded and exhibited will be kept in the archive of Nevşehir Municipality. When it is required, the photographs will be able to use with the aim of a presentation (calendar, agenda, post card etc.) by stating the name of the photograph owner. Additional copyright price will not be paid. Using rights of photographs will belong to owner and Municipality of Nevşehir.
2. All of the photographs sent must be taken by the competitor. All legal responsibilities of copyright violations that may occur belong to the participant in case the images of someone else are used as same or partially.
3. It is considered that the people appearing the photographs sent to the contest allow to be taken their photos and sent to a competition, and to be published the photographs on the internet and other organs of printed publications. Disagreements that may arise from the said use will be under the full responsibility of competitor.
4. The awarded photographs will be published at web site of TFSF - [www.tfsf.org.tr](http://www.tfsf.org.tr) - and - [www.tfsfonayliyarismalar.org](http://www.tfsfonayliyarismalar.org) – and also at our municipality's web site (Municipality of Nevşehir - [www.nevsehir.bel.tr](http://www.nevsehir.bel.tr) -) and take a part in the pages of Almanac-2018 which is a publication of TFSF.
5. A digital catalogue which contains awarded and exhibited photographs will be prepared and can be downloaded from [www.nevsehir.bel.tr](http://www.nevsehir.bel.tr) as of 30 January 2018. A digital catalogue which contains awarded and exhibited photographs will be sent to all participants.
6. The participants who become member of the website <http://tfsfonayliyarismalar.org> and send photograph to this contest shall be deemed to have accepted exactly all terms of conditions.

### **Title of the Works and Submission:**

- Since the contest is organized for the online photograph system, no alternative submission (e-mail, shipping, handing etc.) will be accepted.
- Online submission of the contest photographs will be carried out only by using the below websites and by following the membership and the photograph submission procedures.

- Registration is necessary in order to upload photographs on the given page. Activation of the account can be done by clicking the activation link sent to your e-mail address after your registration.

- Those who already have an account can use their old usernames and passwords.
- Size of the photographs and their titles must be determined beforehand and be kept ready to be loaded on the web page in a single session.
- There cannot be frames or margins on the photographs. No information regarding the identity of the participant such as name, signature, logo, date, etc., must take place on the photographs.
- The photographs must be saved in jpg/JPEG format, at 150-300 dpi resolution, in 7-12 compression quality and with its short edge minimum 1920 pixels and long edge maximum 3200 pixels. Also, the overall file space must be no less than 1 Mb and no more than 4 Mb.
- The title names of each photograph file must be max. 31 letters. Ç, Ğ, İ, Ö, Ş, Ü, ç, ı, ğ, ö, ş, ü characters cannot be used in the title. English letters and underscore ( \_ ) can be used.
- All letters, except the ones in country code and section, must be in lower case.

### **Naming the Files:**

- Name of the file must be maximum 31 characters. English letters and underscore ( \_ ) can be used. Turkish characters ı, ö, ü, ç, ğ, ş must not be used.
- Country code must be written in the first two characters of the file ("TR" for Turkey). For other countries, visit:

- After that the name of photograph owner must be written in maximum 5 characters. (Example: omery or oeril or erily for "Ömer Eril Yılmaz" etc.)
- Next character must be the initial of section (D > Digital).
- The ordinal of photograph must be written with numbers (From 1 to 4) and after that an underscore must be added ( \_ ).
- Name of the photograph after the underscore must be written in such a way that the total number of the characters not to exceed 31.
- Examples: "TRomeryD1\_peri\_bacasi" for the photograph no 1 named "Peri Bacasi" of "Ömer Eril Yılmaz" or "TRomeryD2\_sehir\_meydani" for the photograph no 2 named "Şehir Meydani", etc.
- In the steps of registration on internet or participation to the contest, in case there are errors originating from the user or system, if you send an e-mail to [onlineyarismalar@tfsf.org.tr](mailto:onlineyarismalar@tfsf.org.tr) and give information, the problem will be solved in a short time and the participant will be informed. This e-mail address will only be used for uploading problems; uploading photograph to this website will not mean that you have applied to the contest and participation will not be accepted.
- Municipality of Nevşehir will not be responsible for the possible problems in the process of loading files.

### **Notification of Results:**

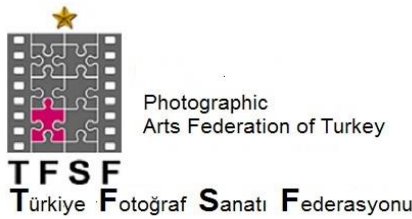

**\*Definition of FIAP “Traditional Photo -TRAD”**

A traditional photograph maintains the original image content with minimal adjustments which should not alter the reality of the scene and should appear natural. Rearranging, replacing, adding to or removing any part of the original image except by cropping is strictly forbidden.
